### **Parent/Student Information**

The Shotgun team will practice at the Coon Creek Trap and Skeet Club located at 5393 Waltz Road Rio Oso. We will practice Trap periodically in the off-season and at least twice a week starting in January. The competitive trap season runs from March through July with 6 tournaments in various locations. Most locations are within the Sacramento area. The State Championships are located in Stockton and will be held in June 2023. The State Championship is a 2-day shoot on a Saturday and Sunday and is usually the 2nd weekend in June. The championship requires 200 shells or 8 boxes of shells. There is a US Open held in Las Vegas each year in July and is normally the 2nd weekend in July. It is a 5-day shoot running Wednesday through Saturday and is a National Championship. Skeet runs concurrent with the trap season and the US Open in July is for Trap, Skeet and Sporting Clays.

We also have a Sporting Clays Team made up of Team members who compete in the Fall. We start practices in September and have 5-series shoots through October and November and a State Championships the 2<sup>nd</sup> weekend in November. Our skeet team is made up of Shotgun team members and the competitive season runs concurrent with Trap. There are 4-series shoots and a state Championship in May. And Nationals in Las Vegas in July is for all 3 venues of trap, Skeet and Sporting Clays. We have Olympic Bunker in the Winter however this is a sport for someone who has a season or 2 of one of the other venues of clay shooting. Olympic Bunker is very challenging and for those pursuing the Olympics.

Needed for each shooter are a shotgun, ear protection, eye protection and an ammo pouch. Ear protection can be anything from muffs to the foam earplugs. Most shotguns used in trap are 12 gauge, but any gauge will work. Most field guns will work, and it does not matter whether the gun is an auto loader, pump or a break open action. In Trap, one shot is fired at a time. The ammo used are target/trap loads which use size 7.5's, 8's, & 9's shot. No hunting loads or other types of ammo can be used on a range.

The trap tournaments each have a \$50 entry fee paid by the team with team fundraiser dollars and require 100 shells or 4 boxes of shells. The price per box at the club is \$8.50 a box or you can buy them at SOS in a box of 100 shells for about \$35. Or you can buy them at the range for \$8.50 per box including the tax. At the practices, we like the shooters to shoot 2 rounds of 25 which would require 2 boxes of shells and we provide 1 box of shells with team fundraiser dollars. We get the club price of \$8 per round of 25 for the clays and we use our fundraiser dollars to pay for practices. Therefore, a practice would cost \$8.50. You pay as you go. There is also a \$35 registration fee for the CY SSA. We receive the NRA grant each year which helps pay for much of the practices and ammo for the shoots once the competitive season staffs. We also have an annual fundraising dinner which generates a significant amount of revenue to offset the costs above for the parents. The only thing you pay for is 1/2 of the ammunition needed.

I encourage and appreciate parent involvement. A parent is required to be at the Safety Training required for each shooter before they can shoot. There will also be make-up safety training sessions when needed. Release and waivers, and medical consent forms must be signed by a parent or guardian before a shooter can participate. Shooters will need transportation to the range for the practices and to the tournaments. Carpooling works well.

I am the head Coach. My Name is Dave Samson. This is my11<sup>th</sup> year coaching the Sutter High School Shotgun team. My contact information is cell phone 530-301-4622 and my e mail is <u>trapteamsutter@.yahoo.com</u>. Call or e mail with any questions.
