**IMPORTANT: PLEASE READ**

Under the terms of the will of the grantor of the Trust, funds from the Trust are to be awarded only to **Yuba and Sutter County students** who will be attending colleges or universities located **within the state of California**.

The Trustees of the Mary M. Aaron Memorial Trust Scholarship Fund are committed to primarily help students that begin their post-secondary education at Yuba College, then move on to other colleges or universities after completing their general education requirements. If funds are available, the Trust grants awards to all qualifying students that are attending Yuba College. When students complete their general education requirements, and are ready to move on to a four-year institution, they may continue to apply for a grant. However, the Trustees' selection process for approving grants after a student leaves Yuba College is more rigorous.

All applications of post-Yuba College students will be carefully evaluated, then selected students may be asked to an interview with the Trustees. Based on the results of this interview process, the Trustees will select students to be awarded grants. The total Trust income each year and the number of students approved, will determine the amount of the post-Yuba College grants. It is the aim of the Trustees for these grants to be of significant help for those students selected, although a particular amount cannot be projected.
